Spring 2021 CAS General Faculty Meeting Minutes March 3, 3:30 PM Via Zoom

- I. Welcome & Dean's Opening Remarks- Dean Stephenson welcomed everyone and shared about the following:
 - a. Members of the CAS Student Advisory Board continue to share their appreciation for the many efforts faculty continue to make during this difficult time. Thank you for all you are doing.
 - b. WUmester continues with many events led by CAS faculty and special exhibits at the Mulvane.
 - c. Corrections project to provide college classes and credit to incarcerated persons launched this spring, with an initial cohort 19 women taking classes. The program is expected to expand in terms of numbers and participating institutions in the fall.
 - d. 89% faculty response rate to first academic progress report. Thank you.
 - e. Student perception ratings in the fall were higher than usual, reflecting tremendous efforts of faculty.
 - f. Strong faculty participation in faculty success groups from the fall and again this spring.
 - g. Announcement about in-person, outdoor commencement for 2020 and 2021 graduates came out this morning via email.
 - h. CAS departments have begun reviewing tenure and promotion requirements. Departments will be asked to consider recommendations of Faculty Affairs Committee to revise requirements in light of COVID-19.
 - i. Work to improve department webpages is ongoing, led by Michaela Saunders. Thanks also to work of chairs.
 - j. Small program review process is underway. Stephenson expressed appreciation for approach Dr. Mazachek is taking to this, which will be thoughtful and data driven. It has not been undertaken as a way to plug a budget deficit. It will consider qualitative aspects of small programs. Stephenson hopes this will be an opportunity to strengthen small programs. First 4 programs to go through this process will be: Art, Political Science, Physics, and Education. Additional small programs will be selected next year. This process will eventually become part of annual review process.
 - k. It does not look like there will be budget cuts this year. Frozen positions will continue. Stephenson is hoping travel funds will be restored next year, as well as research grants and WTE funding.
 - l. CourseLeaf software is coming and will provide a new way to undertake curriculum changes. In the meantime, Rebecca Meador, chair of CFCCC, has done tremendous work navigating the existing system, which has experienced many technical glitches this year.

- m. College Faculty Council will be looking at adopting revised student perception survey questions. For this spring semester, CAS will continue to use the abbreviated survey form adopted during COVID.
- n. New Student Orientations are scheduled to take place over two weeks in June instead of being spread out throughout the summer. Format for advising is still being determined. CAS will communicate additional information as it becomes available.
- o. Chairs have done tremendous work in the last year. Stephenson expressed gratitude.
