Minutes from the meeting

1. Call to order

Kristen Grimmer called the meeting to order.

2. CAS Proposal and Vote 1 (99 credit hour rule)

Kristen Grimmer introduced the first proposal from CAS for the reinstatement of the 99 credit hour rule. The floor was opened for discussion.

Faculty were worried about the deans needing to waive the extra hours in the case of having a major who is taking a minor outside of CAS, such as a business minor. Also, faculty were worried about the fact that the sport business major has a lot of hours in the school of business.

KN faculty said that it would be hard working with the allied health majors and this would make this extra difficult.

Faculty would like an implemented way for either Banner or Degree Works to catch the folks who would need the exception to the rule – for example, if under the degree works audit, when you declare yourself as a business minor, then a note would show up by the 99 credit hour rule saying that the student should double check with the advisor about how to work through this requirement.

Advisors should also be trained, as well as auditors, on the specific programs that students could take where they would be affected by this rule.

All faculty in the division strongly emphasize that the deans need to leave in the language about exceptions to this rule in the

official reinstatement so that students will not be confused by this.

Faculty are especially concerned that potential majors could be turned away if they use the What-If option in Degree Works and then find out they won't meet the 99-credit hour rule.

KN faculty said that their current programs, Sport Management and Allied Health would be okay under this rule.

Faculty said strongly that chairs need to be aware of exceptions that will need to be made for transfer students.

Faculty also want to know what other divisions discussed in relation to this reinstatement of the rule and would like to discuss this further at the general faculty meeting.

Maria Stover made a motion to approve and Park Lockwood seconded the motion. The division passed the motion.

3. CAS Proposal Vote 2 (Bed Rule)

Kristen Grimmer presented the second proposal CAS had sent us and opened the floor for discussion. There was no discussion and Roy Wohl made a motion to approve and Park Lockwood seconded the motion. The division passed the second proposal.

4. Kristen Grimmer presented the packed of information in the general education proposal sent out from Cory Zwikstra and opened the floor for discussion.

Specific feedback the faculty want to emphasize for CAS and the VPAA's office:

- The division strongly recommend NOT GOING FORWARD with the General Education Council mentioned on page 6. The reasons are:
 - o This committee has no purpose and no real rationale
 - o This committee is redundant because CAS has two specific curriculum committees already
 - The faculty strongly disagree with university faculty specifically approving or disproving the classes CAS faculty create or modify because the committee would bring in outside stakeholders that have no real authority in the college and no expertise on what the college teaches
 - O The idea of dealing with student complaints at this level is ludicrous and there are many systems in place already to deal with this, including the chairs, where it should start
 - Any university-level committee for curriculum purposes should include equal representatives from CAS relative to the general education classes provided by the college for undergraduate students.
- The division made these observations about the EN 300 rule:
 - O This change has a major implication for our students
 - o EN 102 is very different from EN 300
 - Option 1 seems best so the EN dept doesn't have to make major changes but may not be best for our students
 - o EN 300 doesn't emphasize grammar, mechanics, spelling, or style but rather writing in general
 - O See a lot of students who have taken 300 but struggle with the mechanics of writing.
 - O This poses a large problem with students who are transfers who have already taken 102 and why wouldn't our students just take 102 at a community college and transfer it in rather than taking the harder 300?
- The division made these comments about the general education proposed changes for specific classes:
 - o What is a scientific literacy course? There is no good definition for this
 - O Would the new science gen ed required classes mean that students always have to take a gen ed and a related lab or could they pick and choose?
 - o No good definition for diversity and inclusion courses

5. Discussion of proposed General Education framework.

- a. Corey Zwikstra summarizes the overarching framework regarding the framework (as outlined in the attachment provided to HUMDIV members).
- b. Questions from division membership
 - i. Is there any possibility that faculty would not make changes?
 - i. Yes, but not likely. Until people articulate fundamental disagreements, it is not likely that the framework will stall.
 - ii. Is the framework something that will be approved via KBOR?
 - iii. Are there reasons we wouldn't want the framework?
 - i. There are overarching implications of KBOR requiring curricular changes.
 - iv. The process seems unorganized. Is this change worth fighting? (Response: Probably not.)
 - v. If we accept this, are we no longer coordinating with KBOR? Are we not now following KBOR. In other words, is this the end of Washburn's independence from KBOR?
 - i. No, we are still considered a coordinating institution. This change indicates their power over us, but technically we are still coordinating, not governed by KBOR.
 - vi. Will KBOR be overseeing our programs? Is there any language that suggests this?
 - i. There is a concern in the framework language that suggests KBOR wants to be able to approve courses within the General Education system. The language can be read to include Washburn.
 - vii. Is it legal for KBOR to say that Washburn is not transfer-friendly? Would this be deemed libel?
 - i. This is unclear. The language as it is currently written is factual, in that KBOR would identify Washburn as an institution that elected not to participate in the General Education transfer system. The language does not indicate that KBOR would label Washburn as not transfer-friendly.
 - viii. How do faculty and chairs in the other divisions feel about this?
 - i. There are concerns in SAS. Some of their programs in Allied Health have concerns about General Education requirements and are hoping their students can receive a waiver. Their programs, like their associates degrees, are highly condensed and require certification, and additional General Education requirements might make graduation difficult for their students to achieve. Jennifer Ball has discussed this waiver as a possible solution.
 - ii. SOBU and SON do not feel that these General Education changes will impact their programs. SOBU has indicated some concern that CAS is highly influential in making General Education changes. Ultimately, CAS will be most affected and SAS will be somewhat affected, as well.
 - ix. Could someone clarify the three English options for navigating EN 101/102 versus EN 101/300?
 - i. All options are sustainable.
 - ii. Option 1
 - In option 1, Washburn would retain EN 101 and EN 300 as the English General Education requirements.
 - b Here are the possible changes.
 - i Washburn could lower the credit-hour requirement to 45 to accommodate associates degrees.
 - ii Washburn could tailor EN 300 to be more discipline-specific (i.e., EN 300 for the Natural Sciences, EN 300 for Nursing, etc.).
 - c Benefits of option 1
 - i Aligns with current composition scholarship and recommendation (there is documented evidence that the 101/300 model better prepares students).
 - ii Program changes would be minimal.

- iii Would provide students with upper-division credit.
- iv Would prepare students interested in academic research within their discipline.

d Drawbacks of option 1

- i EN 102 would transfer in and count for EN 300. Students could take other classes elsewhere (like in high school or at a community college) and not take any writing courses in college.
- ii There would be discrepancies between what direct matriculant students must take to graduate and what transfer students must take.
- iii This complicates advising, as advisors must direct students toward disciplinespecific sections.

iii. Option 2

- a In option 2, Washburn would switch to an EN 101/102 model. The English Department would recommend that programs add EN 300 as a major requirement.
- b Benefits of option 2
 - i This option is perceptually more transfer-friendly and aligns with other KBOR schools adopting this model.
 - ii This is the only option that ensures that all students, regardless of whether they transferred in or were direct matriculates, take a writing course in college. In options 1 and 3, students can take all writing courses before starting college.

c Drawbacks of option 2

- i Many programs are already highly condensed and may be unable to fit another EN course into their requirements.
- ii This approach could prevent the EN 300 essay from being used for written communication and critical thinking USLO assessments.
- iii Student experiences will vary if programs do not add EN 300 or a comparable EN course as a requirement.

iv. Option 3

- a In option 3, EN 101 would be required and EN 102 and EN 300 would be options for the second writing course.
- b Benefits of option 3
 - i Students have substantial choice in their courses.
 - ii This aligns with KBOR expectations.
 - iii This maintains EN 300.

c Drawbacks of option 3

- i It does not commit to either pathway. The difference between EN 102/300 could be unclear to students and would require more intensive advising to direct students toward the best course.
- ii It would be labor-intensive to maintain.
- iii Students could still transfer in credit for both writing courses or take two lower-division writing courses rather than EN 300.

x. Questions and discussion from division membership

- i. Has anyone discussed the possibility of accepting completed General Education requirements from transfer students but keeping our current General Education requirements for students starting out at WU? That way, we could be transfer-friendly without changing all of our programs to what KBOR has outlined?
 - a That is option 1. Associates degrees would have the same writing as our bachelor's degrees. We would have to allow associates students to take EN 300.
 - b If we just have one rule for transfer students (that we accept), that doesn't mean we have to change our curriculum for folks who start here.
 - c The problem with option 1 is that students can take courses elsewhere and transfer them in.

- ii. What about the entirety of General Education?
- iii. How difficult will it be to keep track of different students? Will this create a sense of unfairness among students who must take EN 300?
- iv. Would option 1 still make EN transfer-unfriendly?
 - a No, we could require EN 300 for students who directly matriculate to Washburn from high school. However, EN 102 transferred in would have to count for EN 300.
- v. With option 2, there is a con that programs cannot be compelled to offer a third writing course, so student experiences might vary. We can galvanize people in HUMDIV to advise students to take EN 300. There may be space in our programs to add another writing course.
 - a The framework is 34-35 credit hours. We would be freeing up hours, so could advise students toward EN 300.
- vi. What is the objective? Preserve EN 300? How does this impact writing outcomes?
 - a Research indicates that the transfer of writing skills doesn't happen well from lower to higher division courses. An upper-division writing course helps students write in their upper-division disciplinary courses. In EN 300, students learn how to improve their disciplinary writing. Under the General Education framework, option 2 is the only one that ensures students take EN 300. Others mean students transfer can lower-division writing courses that would count toward their General Education requirement. Option 2 is the only way to ensure that students are taking a writing course in college. There have been varied responses to this approach. Some programs have more space than others. That's why EN is still information-gathering.
- vii. What do the Communication Studies faculty think about these possible options?
- viii. There is the sentiment that an upper-division writing course is necessary to prepare students to be strong communicators. A 300-level course like EN 300 helps prepare students.
 - ix. Students need preparation for the job market and graduate school. An upper-division writing course should be a requirement, as high school credit does not necessarily prepare students for post-graduate professional writing.
 - x. What do the Modern Languages faculty think about these options?
 - a EN 305 is really helpful. Having the required option of either 300 or 305 for the programs would be helpful.
 - b There is a 300-level composition course in Spanish, but it's different because students are learning the language. EN 300 is still transferable to Spanish. Grammar would be most helpful, but any skills transfer over to modern language.
- xi. Will writing courses transfer from high school regardless of whether high school writing instructors have terminal degrees?
 - a Yes.
- xii. When does EN 300 typically fall in a student's college career?
 - a The best time to take EN 300 is the second semester of junior year.
- xiii. Are students who take 100-level courses prepared to write college papers? Instructors are noticing that students are struggling with writing.
 - a Although students benefit from upper-division writing courses specific to their discipline, EN 101 teaches students how to write analyses and write with sources. After completing EN 101, they will still have practiced key writing skills.
- xiv. Lower-division writing courses provide athletic conditioning and upper-division courses help students learn to play the games specific to their disciplines.
- xv. Option 2 is probably the ideal option. The question now is how to fit more writing into the programs.

However, it can be difficult for students to take classes which they do not need (for their majors) while not taking the classes or acquiring the skills they need.
 - b. Why do we even have that requirement? Possibly so that students will take an upper level class (300+ level) for that concentration.
 - c. Should we require minors within NSD but different discipline? It could be helpful, 15-20 credits for a minor where 6+ credits in upper level classes. We will have to undergo small program reviews at some time.
 - d. The concentrations have 30 hours within NSD but outside of their discipline. There are restrictions for concentrations in the catalog, requiring certain number of upper-level credits.
 - e. These numbers are because of Gen Ed, but Gen Ed requirements are changing.
 - f. Some new interdisciplinary minors are not housed in NSD. Can we consider NSD-approved minors?

B. Desired Stoffer renovations

- a. Available funding to improve or renovate classrooms and learning spaces (outside of the classroom).
- b. A rubric is being made to approve what people are requesting. You can pretty much ask for anything as long as you can justify it.
- c. Better for us to collaborate on request to avoid opposing request.
- d. Stoffer 105 renovation plan was previous put on hold because of the pandemic.
- e. The deadline for the current cycle is Friday 3/10/2023.

C. WU101 requirement

- a. Asking different programs to make WU101 their programs' requirement.
- b. Division-specific WU101 rather than generic WU101. There might be a limit on how much you can customize, but they are getting more flexible on the requirements.

c. What can we do to make it more beneficial to our students? WU101 has been connected to better retention.
