## Analysis and Reporting Calendar

Data for all PSLOs are collected annually but only one PSLO per year will be fully analyzed and reported. After two full cycles, the Sociology program committee will conduct an assessment review.

Because the Sociology program committee created a new mission statement, PSLOs, curriculum map, and senior exit survey through the CTET Assessment Grant during spring 2022, we do not have data to report for AY2021-22.

## Stakeholder Involvement

**Faculty:** The Sociology program committee, which consists of all full time Sociology faculty and the Sociology/Anthropology department chair, received a CTET Assessment Grant in spring 2022 to fully revise the Sociology program. The committee's work during the spring 2022 semester was a continuation of their efforts from AY2020-21. Full time sociology faculty will review the assessment process each year at the department's annual retreat (held in August). Part time sociology faculty will be provided all assessment plan documents that outline how to teach and evaluate the course (part time faculty usually teach the 100-level courses where the PSLOs are introduced). The department chair will consult part time faculty each semester for feedback on their courses and program assessment.

**Students:** In classes in which PSLOs are assessed, the specific PSLO are noted in the syllabus and D2L. Advisors discuss the importance of and rationale for taking courses in order (curricular map) with students regularly during advising appointments and when meeting majors at NSO and TSO days. Students complete an exit survey when they graduate where they are able to provide feedback regarding the program including curriculum and assessment. In addition, we discuss program changes with students at student club meetings each year. We also share this information with students at the "Major Meetup" in the fall for incoming students.

**CAS/University:** Full time faculty attend assessment trainings on campus to maintain best practices and have applied and received several CTET Assessment grants to improve program and course assessment strategies. They solicit feedback from college and university stakeholders through the annual reporting process.

**Broader Community:** Our assessment plan and report are posted on our departmental website under "Quality Indicators." The department social media page is open for public comment and allow for student and community feedback on the program. Facets of program assessment, including assignments linked to the PSLOs are highlighted on these public pages. Our departmental newsletter is sent to all current faculty, students, alumni, and external stakeholders and is also posted on the department social media pages and website twice each year.

## Program Assessment Plan Review Cycle

The Program Assessment Plan is reviewed every 3 years.
