Students with a second licensure area in English/language arts, history, or mathematics currently take ED 340 Teaching Adolescents in a Middle Level Environment (3) with both content and field-based work. Changing this course to two hours and creating a practicum in middle school for each content will provide a clear field-based component for both accreditation and licensure requirements.

2. Complete revised description (including program title, requirements, courses within program, credits, and prerequisites)

No changes in program description. No changes in the required number of credit hours for these programs. Prerequisites for ED 340 remain the same. New course descriptions for each of the following courses require concurrent enrollment in ED 340 and the content practicum.
