  - i. Leaving Student Body President for the Law School- Thank you for helping them out. It's helped them expand and do more awesome things! He appreciates the help.
  - ii. New Law School President really values the community. He continues to foster a community between the buildings.
- b. Student Concern with Antonio Martinez
  - i. The impact we have on students is hard. What we do impacts all students. WSGA has passed the student senate fee from \$56.00 to \$70.00. Consider the specifics of the proposal. He says this hurts the most valuable students. In the past few years this has only happened a few times. Since Dr. TLC and Dr. G they haven't seen an increase of \$10, but this \$13 increase will cause a financial strain. Currently the 3% increase will leave the fee outside of the hands of students. 23% increase
  - ii. Every student pays it. These students can't even receive resources. This jump is irresponsible and risking pricing

students out of their education. The student activity fee is the one thing not covered under the Promise Scholarship. Tuition increased last year by 5% with the dismantling of the Department of Education, we will see more fees coming out of the student's pocket. We are going to see potentially consistent 3% increases that will raise our fee significantly. Let's see that we raise our fee this high- but we can't give that money back to students. We'll be at \$96 with the legislation. This fee increase was made with little student input. He was happy there was a committee, but he's sad that it didn't represent the student body. He wants every voice in the population to hear about it.

- iii. WUBOR has never denied a fee increase from student Senate. These fee increases will stay the same and will not go down. What we can do next? He's disappointed in the process and the Executive. Senate, you can propose amendments to the bill. You can change the process as it stands. Student Senate needs to take a more Student Centered approach. When you put a % increase on the fee- we don't have the power. Why would we do that? We don't know what will happen with universities, because we need to be cautious. \$30 is a month of meals.
- iv. Questions: What do we do when can't as WSGA afford to help student organizations? Also how can Student Government take the blame on this?
  - 1. Look at Internal Budgets- do we need this kind of stuff? \$5,000 for organizations and nameplates. We need to run an internal audit.
  - 2. He says we put out a link to these kinds of things, via email. Just like we did for elections.
- v. Are students really going to check email?
  - 1. There needs to be more output. When you put a handout, you have the option to participate. He just wanted us to try.
- vi. We see a voice from a low-income students.

1. It's written that it will increase to \$70 with a 3% increase. It will not raise at the \$58.50. We have an overneeds issue- because Lyft has overspent.
- vii. We will be emailing WUBOR letting them know not to increase greatly with the 3%
- viii. We have to ensure that students, especially those utilizing Lyft, have those opportunities. We must keep up with other entities around campus.
  1. Antonio says that we don't use Lyft/Ride Smart for Drunk Driving.
- ix. We have open meetings and have posted about that.
  1. He still says we should have extended our hand out
- x. Have you heard of Ichabods Moving Forward Fund?
  1. He doesn't like it- you need to use all of the FAFSA, and you can only use it once.
- xi. Ichabods Moving Forward is a subsidized loan that voted one.
- xii. Not many people showed up to the committee. This money is going back into student's hands.
- xiii. This does give students more power and ability to spend.
  1. Raising the student activity fee is not just about him. He's been told by 20+ students that they don't like it. He says that people struggle to speak in Senate.
- xiv. Comparatively speaking, people are going to schools with higher funds. She also urges him and people to come speak to Cabinet
- xv. Raising Student Activity Fee Takes Power Away From Senate?
  1. The 3% does that, as it is now out of our hands.
- xvi. We cut Lyft to its bones. This is an expense that he is able to afford especially compared to other schools. We need to regain some of our spending power.
  1. Antonio criticizes the purchasing of the nameplates and the nametags

- xvii. There's only so much we can do. We get a lot international students who utilize resources. We need to make changes. People need to come and advocate for themselves
  - 1. The involvement issue and the activity issue isn't the job of students. There are people who sit complicit and let it happen and he applauds the administration for doing this.
- xviii. What kind of students did he reach out to? What people did he reach out to?
  - 1. He didn't reach out to people. He's one of these people who had to take a pay cut.
- xix. How familiar are you on the process on this?
  - 1. He says that he believes the fee should be increased.
- xx. We utilized our resources- and we sent out a survey to lyft. This was over a fifth of the budget.
