a. Fred Willer, Topeka Public Schools Foundation

- i. Fred is the Executive Director of the Topeka Public Schools Foundation. He worked at Highland Park High School for a long time and saw that there are a lot of resources that students need that we can help them get access to. We have previously given them funding for their Community Cupboard to make sure that students have access to all of the things that they need. The funding that WSGA provides is absolutely crucial to the upkeep of this program. The way we treat kiddos with various health issues (such as lice) so that we can make sure we keep them in school! We also help to fund sweatsuits for those kiddos that have accidents at school. This process is embarrassing and can actually harm kids in school because it hurts socially and academically. Every nurses station now has the supplies to be able to solve this issue!
