- i. DEI tabling went really well! We are also working on a clothing drive and we would love to collaborate on that! Also working on setting up a "What Were You Wearing" exhibit
- ii. DEI talked about things and gave their bill and resolution favorable status
- e. Chairperson Ross, Special Events Committee
  - i. Events committee is working on establishing how we would like to schedule our social media
  - ii. WSGA will not participate in Yell Like Hell for Homecoming We have people taking point on everything but the tophat, so reach out if you're interested in that!

#### VI. Public Forum I:

- a. Dr. John Fritch, Provost and Vice President of Academic Affairs
  - i. What is a Provost? His job is to focus on academic affairs! The library, student success, Mulvane, KTWU and some other areas report to the Provost. This is a big responsibility! Academics are important at a university, and Provost Fritch is here to uphold that.
  - ii. There are lots of campus moves! This can make things difficult, but we appreciate the optimism of students and the way that we have reacted to the changes. Lots of folks did a lot of work to make sure that we ensured the sanctity of classes and offices and all that they could. There has even been some positive feedback! The goal is to move back into Advisor's Excel Hall in January of 2027. We hope to make physical progress on the Allied Health building prior to that as well. Once again, classrooms will be assigned prior to registration!
  - iii. There have been some curriculum updates: AI and Cybersecurity. There are more AAS degrees with the hope of transferring these to WU proper. We also want to make sure that we are paving the way for other AAS or AA degrees to come to Washburn.
  - iv. We in the Provost office are taking Artificial Intelligence very seriously. This is changing our lives very quickly, but

- universities are notoriously slow moving. They are working diligently to be thoughtful, we want to know what ramifications are and what they look like. We want to make sure that we are looking at AI ethics.
- v. Chairperson Ross: Seeing as how AI is being used more progressively in workplaces, do we have a rough vision on how this will be handled at Washburn and in academics?
  - 1. No. We are working on developing this! We know that in different classes, the standards will be different. #1 use of AI right now is counseling and relationships. That is scary! And new!
- vi. Director Hammes: How do you feel about certain offices using AI?
  - 1. One of the things that we will be discussing is an AI policy. This discussion is hard because AI is always growing and evolving and changing. Where do we want to use it? That is the hard part. There are some things that look like they could be good! We have to figure out what works for us and how we want to proceed.
- vii. Vice President Durst: Please introduce yourself before you begin speaking.
- viii. Senator Mcfan: Are the AA and AAS programs just in discussion or are these things that are actually in the works?
  - 1. A little bit of both! We have added some programs and we are working on adding others, so it's a bit of a mixed bag.
  - ix. Director Kerney: Not long ago, there was an assessment panel about how students feel about assessments. How long does it take for this information to circulate and be used?
    - 1. I am not sure about this particular panel, but this process is typically pretty slow. This usually takes at least a semester as a result of the policy of shared governance

- x. Speaker Timm: One of the good things about Henderson was the balance between student and faculty spaces. Will this balance be the same?
  - 1. More so! The emphasis in the architecture is to make sure that we have spaces that are good for students and faculty, but mostly students! There are a lot of cool movable aspects that we tried to be really intentional about.
- xi. Speaker Timm: There were some complications with other renovations, so if renovation timelines do get changed, how soon with the students know?
  - 1. This would be a thing that we communicate as soon as we know. This impacts way more than faculty, so we need to make sure that we talk with everyone. They are assuring us that it will be ready. This can change! But we will communicate!
- xii. Senator Bourell: We've been looking at the ways that AI can be helpful, but are we also considering the ways in which AI can be harmful?
  - 1. Yes, we have talked about this some. The challenge that we get is that lots of things use the same amount of water and do the same detriment. They are also claiming that they are trying to find ways to make sure that they are more efficient.
- xiii. Senator Bourell: If we did use AI and did cause negative consequences, is there a plan that would stop the use of AI?
  - 1. This is a great question! I haven't really thought about that. This would be a large conversation that we would need to have, so we have to be mindful about how we move forward. We would have to get to a point where we would be ready to use the AI before we would start this conversation. We would find a way to make sure that safe AI use would happen.

- xiv. Director Redington: Benton is...flattened. Is there a plan to reduce the barrier that is blocking campus since they aren't doing construction anymore?
  - 1. I am not 100% sure. Thanks for filling me in about Benton! The plan is to make that an outdoor activity space, so we will try to open that up as soon as possible. The bad news is that we will be adding the space on that north side, so it's unclear how soon that will be opened up.
- xv. President Coulter: Get out of your office more! What was my question...oh, this is about your job! If a student has a problem with a professor, should they start with you or go up a certain chain of command?
  - 1. This usually starts with Danny in the Provost office.
- xvi. President Coulter: President Mazachek will be here in 2 weeks to talk more about campus moves. In the space where Benton was, do you think there is a possibility for outdoor classroom space?
  - 1. That isn't really feasible. People are exposed to weather, allergens, and sun. This does not really work. We've tried at other institutions and it isn't super great.
- xvii. We are trying to find more communal study spaces on campus, especially in a time with lots of other things happening.
- xviii. Director Hammes: How do you keep track of students that are using the study spaces?
  - 1. This is mainly done by observation. They did have a better system in the old library, but right now this is mainly observation.
  - xix. Senator McGill: There is now an iCard swipe to see who is in the library, is that what that is used for?
    - 1. I don't know!
  - xx. Vice President Durst: Sean Bird will be here as well

- xxi. Senator Mcfan: When adding resources to the AA program, do those have to be specific? How do we go about making those changes? Does this have to be specific to communities of color?
  - 1. No. A lot of this is for workforce development. We do this to add to degrees and other things. We want to add more to this campus and identify paths that we would like to use.
- xxii. Thank you! I am more than happy to come back any time you want! There are 9 Mondays left in the semester!
- xxiii. Senator Bourell moves to end the public forum. The motion passes.
- b. Michelle Godinet, Title IX Equal Opportunity Director
  - i. My goal is to explain my position and what that entails. The purpose of the position is to make sure that we are upholding the laws and standards that Equal Opportunity entails. The Title IX aspect deals with sexual harassment. We want to ensure that everyone has equal access to things. This job is also to remove all barriers for all students, faculty, and staff.
  - ii. Sexual Harassment takes many forms. We want to make sure that anyone on campus is able to reach out and get support, so this is what you go to Michelle's office for.
  - iii. We are working on reworking the website and some of their other information forms. We want to make sure that people care and find this information accessible. This does end up being a reactive position a lot of the time, but we want to make it proactive. If people come to you, the goal is to know that you should send them to Michelle.
  - iv. Senator Barbery: If someone were to come to you, is this confidential?
    - 1. What we would look is if they want to file a formal and informal complaint. Formal complaints are exactly that. The fact that you came to the office and what you said is confidential. You will be asked how you wish to proceed. The respondent would be spoken to in order to make sure

that we are getting the desired outcomes. The more people involved, the less confidential the situation ends up being.

- v. Senator Bourell: For students that have been assaulted off campus, but by another student, what would this look like?
  - 1. If there is other behavior that comes onto the campus that we would be able to control. We can do no-contact orders on campus, but we cannot control things that happen off campus. The biggest thing that Michelle can do is share other resources. We can also provide supportive measures where we would separate folks if they have classes or other arrangements together.
- vi. Director Kerney: If there is a student employee against another student, is this student on student, or student on employee?
  - 1. This would still be student to student.
- vii. Speaker Timm: What is classified as discrimination and is it okay to go to you in order to make that determination?
  - 1. Molly Stefes-Herman is the campus advocate. If you tell Molly something, she will keep everything confidential. If you tell another employee, they don't have to keep it confidential; the university will be on notice. There are folks that are required to submit this information to Michelle. There are certain constitutional aspects that Michelle covers in specific.
- viii. Senator McGill: What is the enforcement for a no-contact order on campus?
  - 1. This is something that applies to both parties involved. What happens to one person happens to both parties. If you feel as though this has been violated, contact WUPO, Michelle, or the Student Life Office
  - ix. Senator Bourell: With DEI being targeted in the government, how does this affect this institution?
    - 1. Everyone in this room is covered. There is no such thing as reverse discrimination; discrimination is

discrimination. If someone feels that something does not cover particular groups, Michelle will disagree. We want everyone to be included and have a sense of belonging. There is a list of lots of words that you aren't able to put in the policy, but the moral of the story is that if you feel as though you have been wronged, you need to reach out. There will always be a method of protection.

- x. President Coulter: Is this open to all genders? I just wanted to clarify?
  - 1. The government only recognizes two sexes. There are a lot of questions looming out there. We have bathrooms for males and females and families. We have not made a change there, but we want to make everyone feel as welcome as possible.
- xi. Senator Hinds: If someone is accusing someone else of sexual assault, if this information gets resolved and the allegation is not true, what would your office do to repair the reputation of the accused?
  - 1. There are so many variables that we cannot control. There is a lot of damage being done on various platforms and this is incredibly harmful. If you come to Michelle's office and accuse someone, this will be taken seriously. Michelle will never breach confidentiality. Nobody has ever come to her office with a false accusation; this is incredibly rare in general. If we are talking about policy violation, they can sue in turn, but Michell does not deal with this.
- xii. Senator Adhikari: If a matter of confidentiality between a professor and a student, how do you take action against the professor?
  - 1. If this doesn't have anything to do with sexual harassment or inclusion, this is not something that you would go to Michelle with. Provost Fritch mentioned

other systems and ways that we can get the issue resolved.

xiii. Senator Mcfan: motion to end the public forum passes.

#### VII. New Business I:

- a. SB #052: Club Mathematica
  - i. We are requesting funding for a meeting that already happened. None of the representatives were able to be here. Allocations moved to decrease the amount of funding by 30%.
  - ii. Speaker Timm: There were procedural mishaps. The funding was changed to \$112.50. This amount was reduced as a result of the event already having passed.
  - iii. Parliamentarian Sharp: When we motion, we need to do it right.
  - iv. Bill is passed.
- b. SB #053: Biology Club
  - i. The party came in a week early. This was given favorable status. They are asking for food for an event.
  - ii. Bill is passed.
- c. SB #054: Bookworm Bods
  - i. Funding is being requested for the book for book club. This book was chosen because of the Hispanic author to celebrate Hispanic heritage month!
  - ii. Senator Mcfan: How many copies?
    - 1. 20.
  - iii. President Coulter: Where do the copies of the book go?
    - 1. The student can keep them or we give them to students that ask for them
  - iv. Speaker Timm: move to previous question
  - v. Bill is passed.
- d. SB #055: Bods Baking Club
  - i. BBC is requesting money for ingredients to make cookies.
  - ii. Chairperson Ross: Can I have cookies?
    - 1. Sign up for the meeting
  - iii. Senator Meier: how do I join?
    - 1. BodsConnect

- iv. Senator Mcfan: this will happen on Sunday?
- v. Senator Cervantes-Rodriguez: Who is the faculty advisor?
  - 1. Moddelmog
- vi. Senator Crim: How often do you meet?
  - 1. Once per month
- vii. Chairperson Whaley: Where do you meet? Do you have insta?
  - 1. Plass Kitchenette! We are working on setting up a social media.
- viii. We are trying to make things as allergen friendly as possible!
  - ix. Director Hammes: If you were to join, could you ask to make certain things?
    - 1. You would have more say, for sure! We are open to suggestions!
  - x. Senator McGill: Would you need to increase the resources if there were more folks in the club?
    - 1. We already bought supplies, so we can see this meeting and what we need in the future
  - xi. Chairperson Ross: How many cookies do we make?
    - 1. 24-36 pumpkin and lots more chocolate chip. We plan to give them to org members and library staff
- xii. President Coulter: They will be at Bods Banquet! Do you ever partner with Bods Feeding Bods?
  - 1. They are trying to contact us about ingredients that they cannot use/trying to get rid of.
- xiii. Bill is passed.
- e. SB #056: Spanish Club
  - i. Spanish club is asking for funding for an event to celebrate the independence of Mexico! They need so much money because we want this to be a large event and chartwells is expensive. They will also have activities and prizes!
  - ii. Director Hammes: Your president is my roommate! When is the event?
    - 1. Mon Sep  $29^{th} 5-7pm$
  - iii. Bill is passed.

- f. SB #057: Swing Dancing Club
  - i. The shirts are to promote the club and it is so expensive because they have over 100 members.
  - ii. Bill is passed.
- g. SB #058: Christian Challenge
  - i. Requesting money for a conference in Salina. There are over 70 students registering to go, so we want to cover as much of the cost as possible.
  - ii. Bill is passed.
- h. SB #059: Pre-Health Club I
  - i. Bill 59 and 60 are combined to form bill 67.
  - ii. They want a couple of different things like shirts and materials.
  - iii. Bill 67 is passed.
- i. SB #060: Pre-Health Club II
  - i. Bill is passed.
- j. SB #061: Washburn Association of Percussionists
  - i. Tabled.
- k. SB #062: Washburn Association of Composers
  - i. Tabled.
- 1. SB #063: Washburn Piano and Organ Society
  - i. Tabled.
- m. SB # 064: PickleBods
  - i. Money requested for pizza to raise awareness about the club and promote the tournament that they will be hosting.
  - ii. Chairperson Ross: What is the date of the event?
  - iii. Senator Stevens: What is the time of the event?
  - iv. Director Redington: Is the tournament that night?
    - 1. The tournament will be later in October. You can't pickleball on a full stomach!
  - v. Bill is passed.
- n. SB #066: Nepalese Student Association
  - i. The organization is requesting funding for an event. The money covers, food, venue, decorations, and activities.
  - ii. Senator Cervantes-Rodriguez: When is the event?

- iii. Senator Adhikari: Would it be okay if we move the time of the event?
  - 1. Yes, that is okay.
- iv. Senator Brungardt: This request was put in on Monday and the event is next Wednesday. There were exceptions to the funding policy, so this does not directly follow the funding policy.
  - 1. Speaker Timm: Due to external assurances that there were necessary exceptions made to make this happen, we are still able to make sure that this event can happen.
  - 2. Senator Lloyd: Director Ginn, did you make an exception?
    - a. Yes. This did happen.
- v. Bill is passed.

#### VIII. New Business II:

- a. SB #065: Cabinet Position and Committee Name Change
  - i. Chairperson Whaley introduces the legislation. The administration found it valuable to change the name of the DEI role proactively to the Student Accessibility and Belonging title.
  - ii. Vice President Durst: This was a conversation with Dr. G and we wanted to make sure that we encouraged the conversation. This was a WSGA decision. This is something that we took over to make sure that we were supporting our interests and the interest of students. If we were going to change the name, we wanted to make sure that we changed the name and nothing else about the committee or its goals.
  - iii. Director Kerney: We wanted to be proactive and ensure the safety of those in the committee and WSGA. You don't want to be put in danger as a result of the presidential administration in the US today. We were thoughtful about this. We wanted to be careful. The name will never be perfect, so this is something that we have thought about. We could go back to this eventually and keep the conversation going. The job is not changing at all.

- iv. Chairperson Ross: Is this a temporary change based on the administration?
  - 1. This is an indefinite change. The next admin can change this. It is well within their right.
- v. Director Kerney: WSGA are the only ones that still use this specific language, so we are also doing this just to keep in time
- vi. Senator Brungardt: Are we changing the name everywhere and does this need to be specified?
  - 1. President Coulter: the vague state is better because the full change would be crazy.
- vii. Senator Lloyd: Do we want to add who is doing this and present it back to the senate and should we have someone specifically tasked with updating the documents?
  - 1. We could!
- viii. Director Newfer: Basically, we are going to add another section that would clarify that director could add this information.
  - ix. Senator Lloyd adds a section to clarify that Director Newfer would update all of the governmental documents.
  - x. Speaker Timm: Is this a constitutional change?
    - 1. No.
  - xi. Bill is passed.
- b. SR #001: Supporting the Installation of Pickleball Courts
  - i. This is the first resolution from CCA. We want to move more toward making campus more vibrant! We stand for supporting student wellness and engagement. We don't have pickleball courts, we would like to add them to campus to support students in these ways! This resolution urges the upper administration to consider this kind of action.
  - ii. Speaker Timm: How large is a pickleball court
    - 1. ½ of a tennis court
  - iii. Director Hammes: what is the difference in the courts, aside from the size?
    - 1. There are differences in the lines, as well as the size.
  - iv. President Coulter: Where would the location be?

- 1. There is a lot of construction, so we would kick that back to President Mazachek. This is for review and consideration. This is not under our purview.
- v. President Coulter: Why not just go to Ichabod Grille?
  - 1. We did talk to President Mazachek about this, and she did show some agreement.
- vi. Parliamentarian Sharp: If we had courts on campus, would there be a policy about non-students using the space?
  - 1. We wouldn't be designing the courts. I think it could be a good consideration, but this resolution is just to show interest.
- vii. Senator Smith: Why does the Rec not have enough space for this?
  - 1. The space does not exist for pickleball and there is not always enough to accommodate the needs. The Rec does not have the facilities.
- viii. Senator Motes: The pickleball court surface is a lot different from what we have in the gym.
  - ix. Senator Smith: Why not just invest in the things you need at the Rec?
    - 1. It's a space issue. We also want outdoor space.
  - x. Director Kerney: There is a huge lack of space in the Rec. This is something that we should take seriously. There are other factors that play in here.
  - xi. Senator Bourell: Vote in favor! This improves campus vibrancy! Pickleball is cool!
- xii. Senator Bottom: This just goes to Mazachek?
  - 1. There is no way that we can say this, but this is something that she will see and it has to have an impact on her thought process.
- xiii. Senator McGill: motion to previous question
- xiv. Resolution is passed.
- c. SR #002: Suicide Prevention Awareness

- i. Vote because this is important! We need to bring awareness to this. That is all I have to say.
- ii. Senator Crim: What are we voting for?
  - 1. Bringing awareness to suicide prevention
- iii. Senator Stevens: If this were to be approved, this would go to Mazachek?
  - 1. This goes to the WSGA Administration
- iv. Senator Bottom: Does this go to events? You said events?
  - 1. No, no events are planned
- v. Chairperson Ross: Make an amendment to the first whereas.
- vi. Senator Lloyd: this is leftover from previous legislation, can we get rid of this?
- vii. Director Redington: Amend the 2<sup>nd</sup> and 3<sup>rd</sup> whereas to change the case
  - 1. Cervantes-Rodriguez makes the motion
- viii. Director Newfer: there are punctuation changes that need to be made
  - ix. VP Durst: We need to consider the importance of this resolution. There are lots of parts of life that we don't always see. Check in on people! Be kind and supportive and benevolent.
  - x. Senator Bourell: If you have been effected, take care of yourself. It is not your fault.
  - xi. Senator Barbery: It is important to make sure that if you're worried about losing a relationship for someone that you're worried about. It's better to have them alive.

#### THEREFORE, BE IT ENACTED BY THE WSGA SENATE:
