VII. New Business I:

- a. SB #061: Washburn Association of Percussionists
 - i. The Percussionists, Composers, and Piano and Organ Society are all collaborating together for the same event. They will have a multiple day event where they will have a series of presenters and concerts. There will be a lot of really cool opportunities for all of these incredible musicians.
 - ii. Vice Chair Brungardt motions to combine SB 61, 62, and 63.
 - 1. The bills are combined.
 - iii. SB#73 is passed.
- b. SB #062: Washburn Association of Composers
 - i. SB#73 is passed.

- c. SB #063: Washburn Piano and Organ Society
 - i. SB#73 is passed.
- d. SB #068: Anderson Grant
 - i. Tabled
- e. SB #069: ByteBods
 - i. Tabled
- f. SB #070: Kinesiology Club
 - i. Requesting funding for shirts. They do have shirts every year. They increased the price so that they would have enough money to cover the shirts, regardless of the design that they chose.
 - ii. Parliamentarian Sharp: Can we see the design of the shirts?
 - 1. We could pass our phone around?
 - 2. No, that is okay. You don't have to pass your phone around.
 - iii. President Coulter: You don't have to pass your phone around. Just wear the shirt to senate sometime and we would all be so proud.
 - iv. Bill is passed.
- g. SB #071: Washburn Strings
 - i. The organization is requesting funding for the annual Baroque Bash. The event is this Saturday, October 4th. The event is a large group of musicians that group together and work on a piece and then they will give a performance later in the day. They use the money for the instructors, accompanists, shirts, and food from Chartwells.
 - 1. Vice Chair Brungardt: How much of that funding is being used for the shirts?

- b. Senator Cervantes-Rodriguez, Hispanic Heritage Month
 - i. For the last couple of weeks, I have been trying to bring awareness to Hispanic Heritage Month, so we wanted to do a public forum to bring more awareness to why this is particularly important this year.
 - ii. I refuse to let my family grow up the way that I did; we will not be shamed for being Hispanic.
 - iii. We found out that the Hispanic population makes up the second highest demographic here on campus.
 - iv. There have been a lot of attacks on the Hispanic Community. There are current programs that also attack Hispanic Americans. There are multiple sheriff's offices in the state of Kansas that carry out this attack and work for ICE. The SC recently ruled that ICE can use various methods to essentially racially profile.
 - v. What can we do? We can recognize, support, and educate.
- c. Senator Meier: Thank you for taking the time to make this presentation and share this information with senate.
- d. VP Durst: Thank you for doing this. This is a big month and an important time to be able to support this. There is a lot going on in the news and we have a duty to pay attention and support those that need it the most.
- e. Senator Cervantes-Rodriguez: We have a resolution going through tonight, and this resolution will be based on the verbiage that the governor's proclamation uses.

IX. New Business II:

- a. SR #003: Recognizing Hispanic Heritage Month
 - i. This year's theme is "Honoring the past, inspiring the future."

 The resolution is important because this is something that really affects the community. There is a lot happening and the Shawnee Co Sherriff's office does support ICE and other issues that directly affect this community.

- ii. Vice Chair Brungardt: Make sure that we are aware of spacing and use unanimous consent.
 - 1. This was amended in IA, so we are all good!
- iii. Resolution is passed.
- b. SR #004: Domestic Violence Awareness
 - i. Senator Mcfan: DV is a huge problem. DV is not just romantic relationships, it can be in any relationship. This resolution is to acknowledge this on campus and the Topeka community
 - ii. Chairperson Ross: → Director Redington: Someone should make a friendly amendment
 - iii. Chairperson Ross: slash should be added in and/or in the 3rd whereas.
 - iv. Parliamentarian Sharp: We do still need to vote on these amendments through the senate. There is still a process here.
 - v. Senator Lloyd: A period should be added at the end of Section 1. Originator accepts. No objections.
 - vi. Parliamentarian Sharp → VP Durst: This is also very important. There are a lot of things that happen that go unseen, so it is important to make sure that we recognize these things.
 - vii. Resolution is passed.
- c. SR #005: Freedom of Gender Expression
 - i. Chairperson Whaley: This resolution explains that genderexpansive folks exist, so we need to do a better job of recognizing these folks, even though they are not recognized in legal terms.
 - ii. Senator Bourell: This is super important for so many reasons. Often, these folks are discriminated against and this makes them feel incredibly unwelcome, so we want to make sure that we vote to support this so we can make sure that we keep these spaces open for everyone.
 - iii. Director Newfer: This is a great opportunity to show all of the changes that we are making to the template for legislation.
 - iv. Parliamentarian Sharp: This isn't in the law, but what does Washburn do?

- 1. Dr. TLC: We follow the law
- v. VP Durst: the university follows the law but we want to make sure that we are being representative of all of the folks on campus. Just because WU follows the law, does not mean that WSGA has to.
- vi. Vicechair Brungardt: Changing the name of the DEI committee was to take a target off of our back, but will this resolution put the target right back?
 - 1. Dr. TLC: These resolutions represent what these bodies support. There are people across many campuses that are supporting this same kind of movement. This work remains the same; we are still to support all students. WU has always been open to all people. Those that came before us have still worked to help and be there for you, so please know that we will always be there for you. This resolution would remind everyone that we do still want to be there for our peers and colleagues.

WHEREAS, social isolation, fear, shame, and lack of resources are common barriers and or factors that prevent a person from leaving a domestic violence situation.

THEREFORE, BE IT RESOLVED BY THE WSGA SENATE:

SECTION ONE: WSGA will bring awareness and action by hosting events and posting on social media, to provide information and resources to all Washburn students
